#### Scope/nature of job :

## 1. YP-II under Accounts Section

All the IT related functions of Finance & Accounts section including management and operation of ERP-FMS MIS/Accounting softwares etc. Any other work as assigned by the Authority.

## 2. <u>YP-II under Animal Health & CIF Lab</u>

Collection of samples for three institute projects namely (1. Molecular screening of tick vectors and the host mithun (*Bos frontalis*) for haemoparasites in the states of Nagaland and Arunachal Pradesh 2. Molecular studies on the prevalence of diarrheacausing organisms in mithun" and 3. AICRP network project on Foot and Mouth Disease). In order to the collection of different samples from different mithun inhabited areas and subsequent processing of the samples and molecular works, laboratory diagnosis along with routine parasitological and microbiological works for research purpose. Molecular work and laboratory screening/diagnosis of animals under IRC project and FMD network project. Any other work as assigned by the Authority.

#### 3. YP-II under Animal Physiology & Reproduction Section

Laboratory work including handling of scientific equipment and farm reproductive management (semen collection, AI and pregnancy diagnosis). Any other work as assigned by the Authority.

#### Terms & Conditions:

- 2. The applicant must submit self-attested scanned copies of relevant documents/certificates along with prescribed application form with passport size photograph affixed.
- **3.** Shortlisted candidates for the above mentioned positions shall be informed the date for Walk-In-Interview through email only.
- 4. The shortlisted candidates must bring with them all original documents at the time of interview for verification. The candidate must be present 30 minutes before the interview scheduled date/time for necessary formalities.
- 5. Age limit: The age limit is 21-45 years; relaxation to SC/ST/OBC/PH/ Ex-Serviceman/Women as per the Govt. of India instructions
- 6. The YPs in ICAR are eligible for 08 days leave in a calendar year on pro-rata basis and 02 restricted holidays as per the rules of Govt. of India/ICAR. They are full time workers and required to adhere to the administrative, financial and disciplinary regulations of ICAR-NRCM, regular attendance will be maintained.
- 7. In case of serving candidate, NO OBJECTION CERTIFICATE from his/her employer and experience certificate in original should be produced.
- 8. Initially the period of engagement will be one year, and further extendable for two more years (01 year at a time) subject to requirement of the services of the YP in the organization and satisfactory performance of the candidate after evaluation by the Competent.
