#### **Terms & Conditions:**

- 1. Application addressed to the Director, ICAR-NRC on Mithun, Medziphema, Nagaland alongwith duly filled application form as per prescribed format must be produced at the time of interview.
- 2. The applicant must submit self-attested scanned copies of relevant documents/certificates along with prescribed application form with passport size photograph affixed. Applicants must bring with them all the original documents at the time of interview for verification.
- 3. Only the eligible candidates should come for the interview and must be present 45 minutes before the interview scheduled date/time for necessary formalities.
- 4. The YPs in ICAR are eligible for 08 days leave in a calendar year on pro-rata basis and 02 restricted holidays as per the rules of Govt. of India/ICAR. They are full time workers and required to adhere to the administrative, financial and disciplinary regulations of ICAR-NRCM. Regular attendance will be maintained.
- 5. In case of serving candidate, NO OBJECTION CERTIFICATE from his/her employer and experience certificate in original should be produced.
- 6. Initially the period of engagement will be one year, and further extendable for two more years (01 year at a time) subject to requirement of the services of the YPs in the organization and satisfactory performance of the candidate after evaluation by the Competent.
- 7. Positions are purely temporary, time bound, non-regular and on co-terminus basis with the project. Appointment can be terminated on one month's notice.
