- 4. The shortlisted candidates must bring with them all original documents at the time of interview for verification. The candidate must be present 30 minutes before the interview scheduled date/time for necessary formalities.

- 6. The YPs in ICAR are eligible for 08 days leave in a calendar year on pro-rata basis and 02 restricted holidays as per the rules of Govt. of India/ICAR.
